

FEDERAL REVIEW

As a part of the five year grant, BCHS was required to participate in a Focus Area One Monitoring Protocol. This was a series of off-site telephone interviews during a 1-week period. These discussions focused on BCHS' approaches to staffing structure, program design, education, health services, family services, fiscal infrastructure and grogram governance. There were no areas of non-compliance noted.




2020- 2021 Funded Enrollment

- BCHS is serving 37% of eligible children in Brazoria County based on the Community Assessment.



Health & Disability Services

The health of BCHS children is one of our primary concerns. We provide and/or partner with local agencies to deliver comprehensive services that include preventive screenings and exams such as, immunizations, physical and dental exams, vision and hearing screenings, as well as developmental and mental health screenings (please refer to graphics below). We work closely with families to ensure they identify a medical support service within the community to ensure accessible, continuous, comprehensive, and family centered medical care for years to come.



BCHS is an exceptional place for all children including those with special needs. We are committed to working with families and the local ISD's to ensure that the children, including those with disabilities, receive the comprehensive services they need to meet their developmental, health, and social needs. In addition, we are also committed to continuously meeting the mandated 10 percent of enrollment opportunities for children with disabilities.

Family Engagement

Family Engagement in Head Start and Early Head Start is about building relationships with families that support family well-being; supporting strong relationships between parents and their children; and nurturing ongoing learning and development for both parents and children. The Parent, Family, and Community Engagement (PFCE) Framework is a roadmap for progress in achieving the types of outcomes that lead to positive and enduring change for children and families.








We offer several opportunities for Family Engagement that includes Family Literacy Night, The Fatherhood Program, Monthly Parent Meetings, ARK (Adults Relating to Kids), Family Values Night, Parent Expo, EPEC (Encouraging Parent Engagement Curriculum), Valentine's Dance, and Volunteering Opportunities.

Comprehensive Services to Families



School Readiness

BCHS is a high quality birth to five early learning school with an educational goal that ensures children are ready for school, and families are ready to support their children's learning. BCHS continues to be an early childhood trailblazer with a solid, clear, and inclusive focus on all facets of healthy development, including: physical, cognitive, and social/emotional development; all the ingredients to ensure children are school ready.

BCHS's School Readiness is accomplished and maintained with a three-pronged approach:

- 1. Hiring high quality and qualified Head Start Teachers that have an Associate of Art or Bachelor's Degree in Early Childhood Education; Early Head Start Teachers with a minimum of a CDA with an Infant & Toddler Specialization
- 2. NAEYC Accredited Campuses
- 3. A brain research based curriculum which is aligned with the Head Start Early Learning Framework and The State of Texas Pre-K Guidelines. BCHS implements Creative Curriculum.

BCHS's children are assessed with Teaching Strategies Gold at the beginning (BOY), middle (MOY) and at the end of the year (EOY). Please refer to the table below for the end of year scores.

The Classroom Assessment Scoring System (CLASS) is an observation instrument that assesses the quality of the teacher-child interactions in campus based preschool classrooms. CLASS includes three domains or categories of teacher-child interactions that supports children's learning and development: emotional support, classroom organization and instructional support.
